
The Public Utilities Department provides water and wastewater collection for City of San Diego customers as well as wastewater treatment and disposal services for City of San Diego customers and our regional partners.

- Pure Water Phase One
 - * Resume bid openings in Fall 2020 and begin construction in Spring 2021




